RESPONSIBILITY WAIVER

- I understand that it is my responsibility to consult a physician regarding my participating in all programs offered by Rasamaya, LLC prior to attending my first class.
I understand that it is my responsibility to inform each teacher of any injuries and/or limitations that might affect my practice before each class I attend.
I understand that I am participating in programs that may involve hands on adjustments to my body. I am permitting all teachers and assistants from Rasamaya, LLC to touch and adjust my body in accordance to professional standards.
I acknowledge and understand that participation in some movement classes and structural therapy work entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activities. Without a certain degree of risks, students would not improve their skills and the enjoyment of activities would be diminished. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation is purely voluntary, and I elect to participate in spite of risks.
In consideration of being permitted to participate in the programs at the Rasamaya, LLC, I assume full responsibility for any risks, injuries or damages, known or unknown, which might incur as a result of my participation in the program. I release and agree to indemnify and hold harmless, Rasamaya, LLC and their representatives, officers, to the fullest extent permitted by law. It is expressly agreed that all use of the facilities and premises (including but not limited to stairs, parking areas, walkways) shall be undertaken at my sole risk.
I may occasionally be photographed while taking classes. The photographs are property of Rasamaya, LLC and no compensation will be given to me if Rasamaya, LLC uses these photos for promotional purposes. If I do not want my picture taken it is my responsibility to let the photographer know.

CANCELLATION POLICY

- After the initial 24hrs from the first session all funds paid become non-refundable. Initial packages expire three months from purchase, follow-up packages eight months from purchase. I understand that within the first 24hrs of my initial session I can receive a refund in full if I, or Rasamaya, LLC, decide this is not the right fit.
If I am going to miss a session, it is my responsibility to let the instructor know 24hrs in advance or I will be charged for my session, exceptions are only made in the case of inclement weather or emergencies.
